Award of Contract for the CONSULTANCY SERVICES FOR THE PROPOSED PORT WITH INTEGRATED SHIPYARD FACILITY

WHEREAS, the Philippine Ports Authority (PPA) advertised a Request for Expression of Interest for the Consultancy Services for the Proposed Port with Integrated Shipyard Facility, in the Manila Standard, a newspaper of general nationwide circulation on 02 December 2017 and posted the same in the website of the PPA, PhilGEPS and at a conspicuous place in the PPA premises, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **P** 25,048,170.00;

WHEREAS, in response thereto, two (2) consulting firms secured the Eligibility Documents within the prescribed deadline for submission thereof, namely:

1. Syconsult, Incorporated

2. Science & Vision for Technology, Incorporated

WHEREAS, only Syconsult, Inc. submitted its Eligibility Documents within the prescribed deadline for submission thereof. Science & Vision for Technology, Inc. did not submit their duly accomplished Eligibility Documents;

WHEREAS, after the Eligibility Screening conducted on 12 December 2017, Syconsult, Inc. was declared eligible to bid for the project and automatically considered as shortlisted consultant, pursuant to Head Office-Engineering Projects-Consultancy Resolution No. CON 002-2017 Series of 2017, dated 12 December 2017;

WHEREAS during the opening of the Technical Proposal (First Envelope) conducted on 04 January 2018, Syconsult, Inc. passed the requirements of the First Envelope;

WHEREAS, the Technical Proposal of Syconsult, Inc. was evaluated using the approved criteria for evaluation to determine its rating, as follows:

Experience and Capabilities of Firm
Plan of Approach and Methodology
Quality of Personnel
Total

and after due deliberation by the BAC, Syconsult, Inc. was declared as "passed;"

By 2020, PPA shall have provided globally competitive port services in the Philippines characterized by increased productivity, efficiency, connectivity, comfort, safety, security and environmental sustainability.

WHEREAS, the Financial Proposal of Syconsult, Inc. was opened on 11 January 2018 and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson;

WHEREAS, after evaluation of the financial bid and calculation of the final scores, taking into consideration the technical and financial ratings, the following rating was arrived at:

WHEREAS, Bid Evaluation was conducted on 17 January 2018 to determine arithmetical or computational errors on the bid proposal of Syconsult, Inc. and the Bid Evaluation Report, which was approved by the BAC on 18 January 2018, showed no discrepancies on the bid proposal of Syconsult, Inc.;

WHEREAS, Syconsult, Inc. was declared as the Single Rated Bidder in the amount of $\stackrel{?}{=}$ 24,722,640.00;

WHEREAS, Post-qualification was conducted on 19 January 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by Syconsult, Inc. and in the Post-Qualification Report, approved by the BAC on 24 January 2018, Syconsult, Inc. was declared as the Single Rated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE, as it is hereby RESOLVED, to declare **SYCONSULT, INCORPORATED** as the Single Rated and Responsive Bidder and to recommend the award of contract for the Consultancy Services for the Proposed Port with Integrated Shipyard Facility, in the amount of **TWENTY FOUR MILLION SEVEN HUNDRED TWENTY TWO THOUSAND SIX HUNDRED FORTY PESOS** (P 24,722,640.00), inclusive of taxes, to the said bidder.
