Award of Contract for the
**SAN RICARDO PORT REHABILITATION/IMPROVEMENT PROJECT,
BRGY. BENIT, SAN RICARDO, SOUTHERN LEYTE**
LFP ELS NO. 019-2022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the San Ricardo Port Rehabilitation/Improvement Project, Brgy. Benit, San Ricardo, Southern Leyte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 December 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 180,119,055.35**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted their Technical and Financial Proposals, namely:

1. Vicente T. Lao Construction
2. Sunwest, Incorporated
3. WTG Construction and Development Corporation
4. Khan Kon Chi Construction and Development Corporation

WHEREAS, during the opening of bids on 12 January 2023 at 10:00 a.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope. Vicente T. Lao Construction was declared "failed" for failure to submit the required Certificate of Safety and Health Construction related course issued by DOLE for the Construction Safety and Health Officer. Vicente T. Lao Construction signified its intention to file a request for reconsideration, hence, their Second Envelope was retained by the BAC until the request for reconsideration are resolved;

WHEREAS, the Financial Proposal of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Vicente T. Lao Construction submitted a letter dated 13 January 2023, informing the BAC that they will no longer file a request for reconsideration on their "failed" rating, hence, its Second Envelope was returned unopened and duly received by its authorized representative;

WHEREAS, Bid Evaluation was conducted on 18 January 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 19 January 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of WTG Construction and Development Corporation and Sunwest, Incorporated, as follows;


WHEREAS, Khan Kon Chi Construction and Development Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 178,984,203.57;

WHEREAS, post-qualification was conducted on 24 January 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Khan Kon Chi Construction and Development Corporation and in the Post-Qualification Report, as approved by the BAC on 08 February 2023, Khan Kon Chi Construction and Development Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the San Ricardo Port Rehabilitation/Improvement Project, Brgy. Benit, San Ricardo, Southern Leyte, in the amount of **ONE HUNDRED SEVENTY EIGHT MILLION NINE HUNDRED EIGHTY FOUR THOUSAND TWO HUNDRED THREE PESOS AND 57/100 (P 178,984,203.57)**, inclusive of taxes, to the said bidder.
