WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 36,000,000.00**;

WHEREAS, in response to the said advertisement, only Lockheed Global Security and Investigation Services, Inc./Zemog K9 Training Center, Inc./DSL K9 Services/JV secured and submitted the Bid Documents in the amount of ₱ 25,000.00;

WHEREAS, during the opening of bids on 25 January 2019 at 2:30 p.m., Lockheed Global Security and Investigation Services, Inc./Zemog K9 Training Center, Inc./DSL K9 Services/JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Lockheed Global Security and Investigation Services, Inc./Zemog K9 Training Center, Inc./DSL K9 Services/JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:
