WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Multi-Site Remote Surveillance Equipment and Ancillary Services, in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 21 December 2018, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 425,000,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. KIT Properties/Beyondsight Philippines, Incorporated/iPointeast, Incorporated/Joint Venture
2. EVI Distribution, Incorporated

WHEREAS, during the opening of bids on 28 January 2019 at 10:00 a.m., only KIT Properties/Beyondsight Philippines, Inc./iPointeast, Inc./JV was declared "passing" with the requirements of the First Envelope, while EVI Distribution, Inc. was declared "failed;"

WHEREAS, EVI Distribution, Inc. filed a request for reconsideration on their "failed" rating, and the BAC, in a meeting held on 01 February 2019, after due deliberation, agreed to deny said request for reconsideration;

WHEREAS, the Financial Proposal of KIT Properties/Beyondsight Philippines, Inc./iPointeast, Inc./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 31 January 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 01 February 2019, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of KIT Properties/Beyondsight Philippines, Inc./iPointeast, Inc./JV;

WHEREAS, KIT Properties/Beyondsight Philippines, Inc./iPointeast, Inc./JV was declared as the Single Calculated Bidder in the amount of ₱ 417,963,490.00;

WHEREAS, post-qualification was conducted on 06 - 07 February 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by KIT Properties/Beyondsight Philippines, Inc./iPointeast, Inc./JV and in the Post-Qualification Report, as approved by the BAC on 08 February 2019, KIT Properties/Beyondsight Philippines, Inc./iPointeast, Inc./JV was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KIT PROPERTIES/BEYONDSIGHT PHILIPPINES, INCORPORATED/iPOINTEAST, INCORPORATED/JOINT VENTURE** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of Multi-Site Remote Surveillance Equipment and Ancillary Services, in the amount of **FOUR HUNDRED SEVENTEEN MILLION NINE HUNDRED SIXTY THREE THOUSAND FOUR HUNDRED NINETY PESOS (₱ 417,963,490.00)**, inclusive of taxes, to the said bidder.
