Award of Contract for the PROCUREMENT OF IT RESOURCES (Lot 2 - OEM Branded Laptop Computers (B) BAC-PGCS-11(b)-2017

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Procurement of IT Resources (Lot 2 - OEM Branded Laptop Computers (B), in the Manila Standard, a newspaper of general nationwide circulation on 15 December 2017 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **P** 58,250,000.00;

WHEREAS, in response to the said advertisement, two (2) prospective bidders submitted the Bid Documents in the amount of  $\stackrel{\square}{=}$  25,000.00, namely:

- 1. Columbia Technologies, Incorporated
- 2. S1 Technologies, Incorporated

WHEREAS, only Columbia Technologies, Inc. dropped their Technical and Financial Proposals, while S1 Technologies, Inc. submitted its letter of withdrawal from participating in the bidding, dated 10 January 2018, and the BAC, finding the reasons to be meritorious, accepted their withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 10 January 2018 at 2:00 p.m., Columbia Technologies, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Columbia Technologies, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 16 January 2018 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 17 January 2018, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Columbia Technologies, Inc.;

WHEREAS, Columbia Technologies, Inc. was declared as the Single Calculated Bidder in the amount of  $\stackrel{1}{\text{--}}$  57,001,120.00;

WHEREAS, post-qualification was conducted on 19 January 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by Columbia Technologies, Inc. and in the Post-Qualification Report, as approved by the BAC on 23 January 2018, Columbia Technologies, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **COLUMBIA TECHNOLOGIES, INCORPORATED** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of IT Resources (Lot 2 - OEM Branded Laptop Computers (B), in the amount of **FIFTY SEVEN MILLION ONE THOUSAND ONE HUNDRED TWENTY PESOS** (**P 57,001,120.00**), inclusive of taxes, to the said bidder.
