Award of Contract for the PROCUREMENT OF IT RESOURCES (Lot 4 – Laser Printer with Wireless LAN) BAC-PGCS-11(d)-2017

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Procurement of IT Resources (Lot 4 - Laser Printer with Wireless LAN), in the Manila Standard, a newspaper of general nationwide circulation on 15 December 2017 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **P** 1,904,000.00;

WHEREAS, in response to the said advertisement, four (4) prospective bidders secured Bid Documents in the amount of $\not= 1,000.00$, namely:

- 1. DCI International IT Solution and Services Corporation
- 2. Link Network Solutions, Incorporated
- 3. Agile Techfrontier Corporation
- 4. Columbia Technologies, Incorporated

WHEREAS, only three (3) bidders dropped their Technical and Financial Proposals, namely: DCI Int'l IT Solution and Services Corp., Link Network Solutions, Inc. and Agile Techfrontier Corp. Columbia Technologies, Inc. did not submit their bid documents nor submitted a letter of withdrawal from participating in the bidding before the deadline for submission of bids;

WHEREAS, during the opening of bids on 10 January 2018 at 2:00 p.m., only Link Network Solutions, Inc. was declared "passing" with the requirements of the First Envelope. DCI Int'l IT Solution and Services Corp. and Agile Techfrontier Corp. were declared "failed";

WHEREAS, DCI Int'l IT Solution and Services Corp. filed a request for reconsideration on their "failed" rating, and the BAC, in a meeting held on 17 January 2018, after due deliberation, agreed to deny said request for reconsideration. The Second Envelope of Agile Techfrontier Corp. was returned unopened and duly received by its authorized representative after signifying no intention to file a request for reconsideration;

WHEREAS, the Financial Proposal of Link Network Solutions, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 16 January 2018 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 17 January 2018, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Link Network Solutions, Inc.;

WHEREAS, Link Network Solutions, Inc. was declared as the Single Calculated Bidder in the amount of ₽ 1,269,152.00;

WHEREAS, post-qualification was conducted on 18 January 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by Link Network Solutions, Inc. and in the Post-Qualification Report, as approved by the BAC on 23 January 2018, Link Network Solutions, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **LINK NETWORK SOLUTIONS**, **INCORPORATED** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of IT Resources (Lot 4 - Laser Printer with Wireless LAN), in the amount of **ONE MILLION TWO HUNDRED SIXTY NINE THOUSAND ONE HUNDRED FIFTY TWO PESOS** (\$\mathbb{P}\$1,269,152.00), inclusive of taxes, to the said bidder.
