WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of Iloilo Clustered Project I, ICPC, Fort San Pedro, Ports of Dumangas, Iloilo and Jordan, Guimaras, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 December 2018, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 99,481,556.20**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. F. Gurrea Construction, Incorporated
2. Hi-Tone Construction & Development Corporation/KXBG Construction and Development Corporation/Joint Venture

WHEREAS, during the opening of bids on 17 January 2019 at 3:00 p.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 22 January 2019 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 23 January 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of F. Gurrea Const., Inc.;

WHEREAS, despite said discrepancies, the ranking of the two (2) bidders were not affected, hence Hi-Tone Const. & Dev't. Corp./KXBG Const. and Dev't. Corp./JV was declared as the Lowest Calculated Bidder in the amount of ₱ 97,430,211.90;

WHEREAS, post-qualification was conducted on 29 January 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Hi-Tone Const. & Dev't. Corp. /KXBG Const. and Dev't. Corp./JV and in the Post-Qualification Report, as approved by the BAC on 01 February 2019, Hi-Tone Const. & Dev't. Corp. /KXBG Const. and Dev't. Corp./JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **HI-TONE CONSTRUCTION & DEVELOPMENT CORPORATION/KXBG CONSTRUCTION AND DEVELOPMENT CORPORATION/JOINT VENTURE** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of Iloilo Clustered Project I, ICPC, Fort San Pedro, Ports of Dumangas, Iloilo and Jordan, Guimaras, in the amount of **NINETY SEVEN MILLION FOUR HUNDRED THIRTY THOUSAND TWO HUNDRED ELEVEN AND 90/100 PESOS (₱ 97,430,211.90)**, inclusive of taxes, to the said bidder.
