PHILIPPINE PORTS AUTHORITY'S CORE APPLICATION SYSTEM**  
(BAC-PGCS-120-2022)

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Procurement of Technical Support and Maintenance of the Philippine Ports Authority's Core Application System, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 12 December 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 17,000,000.00**;

WHEREAS, in response to the said advertisement, only Diversified Infrastructure and Architectural Development Works Corporation secured the Eligibility Documents;

WHEREAS, after the Eligibility Screening conducted on 20 December 2022, Diversified Infrastructure and Architectural Development Works Corporation was declared eligible to bid for the project;

WHEREAS, during the opening of the Technical Proposals (First Envelope) conducted on 23 January 2023 at 10:00 a.m., Diversified Infrastructure and Architectural Development Works Corporation passed the requirements of the First Envelope;

WHEREAS, the Technical Proposal of Diversified Infrastructure and Architectural Development Works Corporation was evaluated using the approved criteria for evaluation to determine its rating, as follows:

Criteria	Weighted Percentage
I. Firm's Experience	15 %
II. Quality of Key Members to be assigned	60 %
III. Plan of Approach and Methodology	25 %
Total	100 %

and after due deliberation by the BAC, Diversified Infrastructure and Architectural Development Works Corporation was declared as "passed;"

WHEREAS, the Financial Proposal of Diversified Infrastructure and Architectural Development Works Corporation was opened on 01 February 2023 and declared “passing” with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows;

WHEREAS, after evaluation of the financial bid and calculation of the final scores, taking into consideration the technical and financial ratings, the following ratings were arrived at;

WHEREAS, Bid Evaluation was conducted on 07 February 2023 to determine if there were arithmetical or computational errors on the bid proposal of Diversified Infrastructure and Architectural Development Works Corporation and the Bid Evaluation Report, which was approved by the BAC on 08 February 2023, showed no discrepancies on the bid proposal;

WHEREAS, Diversified Infrastructure and Architectural Development Works Corporation was declared as the Single Rated and Responsive Bidder in the amount of ₱ 16,999,060.11;

WHEREAS, Post-qualification was conducted on 10 February 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Diversified Infrastructure and Architectural Development Works Corporation and in the Post-Qualification Report, as approved by the BAC on 17 February 2023, Diversified Infrastructure and Architectural Development Works Corporation was declared as the Single Rated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE, as it is hereby RESOLVED, to declare **DIVERSIFIED INFRASTRUCTURE AND ARCHITECTURAL DEVELOPMENT WORKS CORPORATION** as the Single Rated and Responsive Bidder and to recommend the award of contract for the Procurement of Technical Support Services for the Philippine Ports Authority's Core Application, in the amount of **SIXTEEN MILLION NINE HUNDRED NINETY NINE THOUSAND SIXTY PESOS AND 11/100 (₱ 16,999,060.11)**, inclusive of taxes, to the said bidder.


