BAC-PGCS-31-2017

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Procurement of Twelve (12) Units of Body Scanner Machines, in the Manila Standard, a newspaper of general nationwide circulation on 27 November 2017 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₱ 168,000,000.00**;

WHEREAS, in response to the said advertisement, two (2) prospective bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

1. Boston Home, Incorporated
2. Black Water Resources, Inc./Montenegro Defence Industry /Joint Venture

WHEREAS, only Boston Home, Incorporated dropped their Technical and Financial Proposals in the bid box before the prescribed deadline for submission of bid documents while Black Water Resources, Inc./Montenegro Defence Industry/JV submitted its handwritten letter of withdrawal from participating in the bidding, dated 07 February 2018, and the BAC, finding the reason to be meritorious, accepted their withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 07 February 2018 at 2:00 p.m., Boston Home, Incorporated was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Boston Home, Incorporated was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 13 February 2018 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 14 February 2018, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Boston Home, Incorporated;


WHEREAS, Boston Home, Incorporated was declared as the Single Calculated Bidder in the amount of ₱ 167,760,000.00;

WHEREAS, post-qualification was conducted on 19 February 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by Boston Home, Incorporated and in the Post-Qualification Report, as approved by the BAC on 20 February 2018, Boston Home, Incorporated was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BOSTON HOME, INCORPORATED** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of Twelve (12) Units of Body Scanner Machines, in the amount of **ONE HUNDRED SIXTY SEVEN MILLION SEVEN HUNDRED SIXTY THOUSAND PESOS (₱ 167,760,000.00)**, inclusive of taxes, to the said bidder.




