Award of Contract for the CONSULTANCY SERVICES FOR THE CONDUCT OF FEASIBILITY STUDIES AND FORMULATION OF MASTER PLANS AT SELECTED PORTS

WHEREAS, the Philippine Ports Authority (PPA) advertised a Request for Expression of Interest for the Consultancy Services for the Conduct of Feasibility Studies and Formulation of Master Plans at Selected Ports, in the Manila Standard, a newspaper of general nationwide circulation on 20 December 2017 and posted the same in the website of the PPA, PhilGEPS and at a conspicuous place in the PPA premises, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₽ 23,019,568.39**;

WHEREAS, in response thereto, three (3) consulting firms secured and submitted their Eligibility Documents within the prescribed deadline for submission thereof, namely:

- 1. Science & Vision for Technology, Inc./Syconsult, Inc./JV
- 2. Philipp's Technical Consultants Corp./Cest, Inc./JV
- 3. Schema Konsult, Inc.

WHEREAS, after the Eligibility Screening conducted on 04 January 2018, the three (3) consultants were declared eligible to bid for the project and automatically considered as shortlisted consultant, pursuant to Head Office-Engineering Projects-Consultancy Resolution No. CON 001-2018 Series of 2018, dated 04 January 2018;

WHEREAS during the opening of the Technical Proposal (First Envelope) conducted on 06 February 2018, only Science & Vision for Technology, Inc./Syconsult, Inc./JV and Philipp's Consultants Corp./Cest, Inc./JV passed the requirements of the First Envelope. Schema Konsult, Inc. was declared "failed" hence, its Second Envelope was returned unopened and duly received by its authorized representative after signifying no intention to file a request for reconsideration;

WHEREAS, the Technical Proposals of the two (2) consultants were evaluated using the approved criteria for evaluation to determine its rating, as follows:

WHEREAS, the Financial Proposals of the two (2) consultants were opened on 14 February 2018 and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson;

WHEREAS, after evaluation of the financial bids and calculation of the final scores, taking into consideration the technical and financial ratings, the following ratings were arrived at:

WHEREAS, Science & Vision for Technology, Inc./Syconsult, Inc./JV was declared as the Highest Rated Bidder in the amount of ₽ 22,481,356.00;

WHEREAS, Post-qualification was conducted on 21 February 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by Science & Vision for Technology, Inc./Syconsult, Inc./JV and in the Post-Qualification Report, approved by the BAC on 23 February 2018, Science & Vision for Technology, Inc./Syconsult, Inc./JV was declared as the Highest Rated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE, as it is hereby RESOLVED, to declare SCIENCE & VISION FOR TECHNOLOGY, INCORPORATED/SYCONSULT, INCORPORATED/JOINT VENTURE as the Highest Rated and Responsive Bidder and to recommend the award of contract for the Consultancy Services for the Conduct of Feasibility Studies and Formulation of Master Plans at Selected Ports, in the amount of TWENTY TWO MILLION FOUR HUNDRED EIGHTY ONE THOUSAND THREE HUNDRED FIFTY SIX PESOS (\$\mathbb{P}\$ 22,481,356.00), inclusive of taxes, to the said bidder.
