Award of Contract for the
**PROPOSED DREDGING OF PORTS OF POCTOY AND AMBULONG,
ROMBLON, PORT OF BUYABOD, MARINDUQUE**
LFP BGS NO. 053-2018

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of Ports of Poctoy and Ambulong, Romblon, Port of Buyabod, Marinduque, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 December 2018, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 107,533,249.69**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. Kwan Sing Construction Corporation
2. Khan Kon Chi Construction and Development Corporation

WHEREAS, during the opening of bids on 17 January 2019 at 11:00 a.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

1. KWAN SING CONST. CORP.	₱ 100,010,096.24
2. KHAN KON CHI CONST. AND DEV'T. CORP.	₱ 105,310,620.38

WHEREAS, Bid Evaluation was conducted on 22 January 2019 to determine if there were arithmetical or computational errors on the submitted bids. Kwan Sing Const. Corp. was declared as the Lowest Calculated Bidder in the amount of ₱ 100,010,096.24, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, post-qualification was conducted on 24 January 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Kwan Sing Const. Corp. and in the Post-Qualification Report, as approved by the BAC on 01 February 2019, Kwan Sing Const. Corp. was declared post-disqualified for the reason that during the conduct of post-qualification, the equipment pledged by the contractor for the project was not available for inspection;

WHEREAS, Post-Qualification was conducted on the Second Lowest Bidder, Khan Kon Chi Const. and Dev't. Corp. on 09 February 2019 and in the Post-Qualification Report approved by the BAC on 11 February 2019, Khan Kon Chi Const. and Dev't. Corp. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of Ports of Poctoy and Ambulong, Romblon, Port of Buyabod, Marinduque, in the amount of **ONE HUNDRED FIVE MILLION THREE HUNDRED TEN THOUSAND SIX HUNDRED TWENTY AND 38/100 PESOS (P 105,310,620.38)**, inclusive of taxes, to the said bidder.
