



BAC RESOLUTION DECLARING FAILURE OF BID

BAC RESOLUTION NO. SVP-03-2022

ONE (1) LOT PROVISION OF FREIGHT SHIPPING SERVICES FOR PPA, PMO ZAMBOANGA FROM MARCH 16 TO DECEMBER 31, 2022 WITH AN ABC OF PHP100,000.00

WHEREAS, the Philippine Ports Authority, PMO Zamboanga, through its Bids and Awards Committee (BAC) and in accordance with the Revised IRR of RA 9184 posted and advertised the Invitation to Bid including the Bidding Documents for the One (1) Lot Provision of Freight Shipping Services for PPA PMO Zamboanga from March 16 to December 31, 2022, on February 21 to 28, 2022 in the PPA Procurement Webpage, Philippine Government Electronic Procurement System (PhilGEPS), PMO Bulletin Boards.

WHEREAS, the BAC sent Request for Quotations (RFQs) to three (3) suppliers, namely 1.) JRS Business Corporation; 2.) LIBCAP Super Express Corporation, and 3.) J&T Express.

WHEREAS, on March 1, 2022, at 2:00PM the BAC received the price quotation of LIBCAP Super Express Corporation in the amount of Php89,473.00 and declared as single quotation for the procurement of One (1) Lot Provision of Freight Shipping Services for PPA PMO Zamboanga from March 16 to December 31, 2022.

WHEREAS, on March 2, 2022, at 2:00PM, the BAC declared as failure due to the submission of incomplete entries in the quotation of the supplier.

NOW THEREFORE, We, the Members of the PMO-Zamboanga Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

To declare a failure of bid for the procurement of **ONE (1) LOT PROVISION OF FREIGHT SHIPPING SERVICES FOR PPA, PMO ZAMBOANGA FROM MARCH 16 TO DECEMBER 31, 2022, WITH AN ABC OF PHP100,000.00** and will be subject for reposting.


To recommend for approval by the Port Manager of the PPA, PMO-Zamboanga, Zamboanga City the foregoing findings.
