Award of Contract for the  
**REPAIR, REHABILITATION AND MAINTENANCE OF THE TWO (2) EXISTING  
PPA VESSEL TRAFFIC MANAGEMENT SYSTEM (VTMS) AT THE  
PORTS OF MANILA AND BATANGAS**

WHEREAS, the Administrative Services Department (ASD), submitted to the BAC-Procurement of Goods and Consultancy Services, a request for the Repair, Rehabilitation and Maintenance of the Two (2) Existing PPA Vessel Traffic Management System (VTMS) at the Ports of Manila and Batangas, under the Alternative Method of Procurement through Direct Contracting (Single Source Procurement), with an Approved Budget for the Contract (ABC) of **₱ 330,000,000.00**;


WHEREAS, Direct Contracting may be resorted to under the condition that the goods are sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the government;


WHEREAS, the Philippine Ports Authority (PPA) BAC-PGCS sent a Request for Quotation to Japan Radio Co., Ltd. (JRC), Philippine Branch Office, the exclusive distributor of the existing VTMS of PPA;

WHEREAS, JRC submitted its proposal and quotation for the above project in the amount of **₱ 329,827,680.00**, inclusive of 12% VAT;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the Award of Contract for the Repair, Rehabilitation and Maintenance of the Two (2) Existing PPA Vessel Traffic Management System (VTMS) at the Ports of Manila and Batangas, in the amount of **THREE HUNDRED TWENTY NINE MILLION EIGHT HUNDRED TWENTY SEVEN THOUSAND SIX HUNDRED EIGHTY PESOS (₱ 329,827,680.00)**, to **JAPAN RADIO CO., LTD. (JRC), PHILIPPINE BRANCH OFFICE.**
