**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROVISION OF SECURITY SCREENING MACHINE OPERATORS FOR
PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICES AND
TERMINAL MANAGEMENT OFFICES/PORTS**
BAC-PGCS-102-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Provision of Security Screening Machine Operators for Philippine Ports Authority, Port Management Offices and Terminal Management Offices/Ports, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 05 March 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 148,805,224.85**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents and submitted their Technical and Financial Proposals in the amount of **₱ 50,000.00**, namely:

1. Commander Security Services Inc.
2. Lockheed Global Security and Investigation Services, Inc.

WHEREAS, during the opening of bids on 30 March 2021 at 2:00 p.m., the two (2) bidders, were declared "failed" with the requirements of the First Envelope;

WHEREAS, Commander Security Services Inc. submitted each technical proposals with paper cover and fastener, hence was automatically disqualified for its failure to comply with the bid submission required under Clause 15 of the Bid Data Sheet of the Bidding Documents, which states that "xxx All bid documents shall be book bound, hard bound and properly labelled with index tabs";

WHEREAS, likewise Lockheed Global Security and Investigation Services, Inc. was declared "failed" for failure to submit the following:

1. ISO 9001:2015 Certification
2. No proof of compliance with the requirement for the Radiation Survey Meter.

WHEREAS, Lockheed Global Security and Investigation Services, Inc. signified no intention to file a request for reconsideration;


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Provision of Security Screening Machine Operators for Philippine Ports Authority, Port Management Offices and Terminal Management Offices/Ports, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides that "the BAC shall declare the bidding a failure when: xxx xxx xxx b) all prospective bidders are declared ineligible; xxx xxx xxx."
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Bidding for the Provision of Security Screening Machine Operators for Philippine Ports Authority, Port Management Offices and Terminal Management Offices/Ports held on 30 March 2021, which was declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 017-2021 Series of 2021, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
