WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Tactical Uniforms for Port Police Personnel for CY 2022, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 01 March 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 5,000,000.00**;

WHEREAS, in response to the said advertisement, only CKDiaz General Merchandise secured the Bid Document in the amount of ₱ 5,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 22 March 2022 at 2:00 p.m., CKDiaz General Merchandise was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of CKDiaz General Merchandise was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 29 March 2022 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 30 March 2022, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of CKDiaz General Merchandise;


WHEREAS, CKDiaz General Merchandise was declared as the Single Calculated Bidder in the amount of ₱ 4,817,400.00;

WHEREAS, post-qualification was conducted on 31 March 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by CKDiaz General Merchandise and in the Post-Qualification Report, as approved by the BAC on 06 April 2022, CKDiaz General Merchandise was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **CKDIAZ GENERAL MERCHANDISE** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply and Delivery of Tactical Uniforms for Port Police Personnel for CY 2022, in the amount of **FOUR MILLION EIGHT HUNDRED SEVENTEEN THOUSAND FOUR HUNDRED PESOS (PHP 4,817,400.00)**, inclusive of taxes, to the said bidder.


