**BAC-PGCS-004-2022**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of HEPA-Certified Air Purifiers (Phase II), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 04 March 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 10,000,000.00**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of **₱ 10,000.00** and submitted their Technical and Financial Proposals, namely;

1. E. Aglahi Urban Builders
2. Asiaprime Commodities Corp.
3. ASX Trading

WHEREAS, during the opening of bids on 29 March 2022 at 10:00 a.m. E. Aglahi Urban Builders was declared "passing" with the requirements of the First Envelope. Asiaprime Commodities Corp. and ASX Trading were declared "automatically disqualified" for failure to comply with the required bid submission under Clause 15 of the Bid Data Sheet of the Bidding Documents, which states that "xxx All bid documents shall be book bound, hard bound and properly labelled with index tabs";

WHEREAS, ASX Trading submitted its Technical Proposals which are fastened with plastic/soft cover, while Asiaprime Commodities Corp. submitted its Technical Proposals without index tabs;

WHEREAS, the Second Envelopes of Asiaprime Commodities Corp. and ASX Trading were returned unopened and duly received by their authorized representatives;

WHEREAS, the Financial Proposal of E. Aglahi Urban Builders was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 05 April 2022 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 06 April 2022, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of E. Aglahi Urban Builders;

WHEREAS, E. Aglahi Urban Builders was declared as the Single Calculated Bidder in the amount of ₱ 9,988,770.00;


WHEREAS, post-qualification was conducted on 08 April 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by E. Aglahi Urban Builders and in the Post-Qualification Report, as approved by the BAC on 18 April 2022, E. Aglahi Urban Builders was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **E. AGLAHI URBAN BUILDERS** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply and Delivery of HEPA-Certified Air Purifiers (Phase II), in the amount of **NINE MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND SEVEN HUNDRED SEVENTY PESOS (PHP 9,988,770.00)**, inclusive of taxes, to the said bidder.
