**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROCUREMENT OF PEST CONTROL SERVICES FOR PPA HEAD OFFICE,
MOTORPOOL, PPATI, GAD CENTER AND RECORDS STORAGE FACILITY
BAC-PGCS-073-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 16 March 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 2,470,000.00**;

WHEREAS, in response to the said advertisement, only D-Three Management Services secured the Bid Documents and submitted its Technical and Financial Proposals in the amount of **₱ 5,000.00**;

WHEREAS, during the opening of bids on 28 April 2021 at 10:00 a.m., the lone bidder, D-Three Management Services, was declared "failed" in the requirements of the First Envelope for the following reasons:

1. The solutions and compounds for Rodents and Crawling Pets are not included in the brochure.
2. The brochure for Flying Insects provides that the solutions and compounds are flammable.
3. Certificate of personnel trained to operate a Termite Tracking Device issued by the manufacturer of the equipment was not submitted.

WHEREAS, D-Three Management Services signified its intention to file a request for reconsideration, however, no request for reconsideration was filed by D-Three Management Services within the prescribed deadline for submission thereof;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

SUBJECT : **Resolution Declaring Failure of Bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility**



This has reference to the Opening of Bids for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility held on 28 April 2021, which was declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 036-2021 Series of 2021, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
