**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
SUPPLY AND DELIVERY OF HEPA-CERTIFIED AIR PURIFIERS  
BAC-PGCS-009-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of HEPA-Certified Air Purifiers, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 19 April 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 5,000,000.00**;

WHEREAS, in response to the said advertisement, only Inhail Trading secured the Bid Documents and submitted its Technical and Financial Proposals in the amount of **₱ 10,000.00**;

WHEREAS, during the opening of bids on 11 May 2021 at 2:00 p.m., the lone bidder, Inhail Trading, was declared "failed" in the requirements of the First Envelope for failure to indicate compliance on the following technical specifications:

WHEREAS, Inhail Trading signified no intention to file a request for reconsideration, hence they were notified that their unopened Second Envelope will be returned by the BAC;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply and Delivery of HEPA-Certified Air Purifiers, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Bidding for the Supply and Delivery of Hepa-Certified Air Purifiers held on 11 May 2021, which was declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible; xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 037-2021 Series of 2021, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
