RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PORT TERMINAL MANAGEMENT CONTRACT FOR THE CLUSTERED PORTS OF TABLAS (ODIONGAN) AND CARMEN, PROVINCE OF ROMBLON

BAC-PTMC-02-2024

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Port Terminal Management Contract (PTMC) for the Clustered Ports of Tablas (Odiongan) and Carmen in The Manila Times, PPA website and in conspicuous places in the PPA premises on 15 March 2024;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 218,261,095.99, exclusive of all taxes;

WHEREAS, in response to the said advertisement, Golden Pea Arrastre and Stevedoring Services (GPASS) and the Joint Venture of TCSC Corp. and Roadbook Centre Inc. secured the Bid Documents in the amount of Php 100,000.00;

WHEREAS, during the deadline for submission of bids, GPASS dropped its technical and financial bid on time, while the Joint Venture of TCSC Corp. and Roadbook Centre Inc. did not drop its bid;

WHEREAS, during the Opening of Bids on 06 May 2024 at 2:00 p.m., GPASS was rated "failed" with the Eligibility and Technical Bid based on the following grounds:

 Failure to meet at least two (2) years' experience in providing port terminal management services/cargo handling services or other related port services, as indicated in completed and ongoing contracts;

 Failure to meet the paid-up capital which should not be less than thrice the minimum first year Concession fee of the port subject of the bidding;

3) Failure to submit the complete qualification and experience data of the key personnel; and

4) Failure to meet the minimum standards for the Port Productivity Commitments (Key Performance Indicator).

WHEREAS, the Joint Venture of TCSC Corp. and Roadbook Centre Inc. submitted subsequently a Letter of Withdrawal;

WHEREAS, considering that the lone bidder failed to comply with the Eligibility and Technical Bid requirements, the BAC-PTMC, after a motion duly made and properly seconded, declared the bidding for the Port Terminal Management Contract for the Clustered Ports of Tablas (Odiongan) and Carmen a failure pursuant to Section 24 (c) of

the Guidelines for the Selection and Award of Contracts Under the Port Terminal Management Regulatory Framework (PPA AO No. 12-2018), which provides to wit:

"Section 24. Failure of Bidding

The BAC shall declare the bidding a failure and conduct a rebidding with re-advertisement and/or posting, after a re-evaluation of the terms, conditions, and specifications of the first bidding, when:

c) All bids fail to comply with the Eligibility, Technical and Financial bid requirements.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to recommend the following:

- Recommend to the General Manager as Approving Authority, that the bidding for the Port Terminal Management Contract for the Clustered Ports of Tablas (Odiongan) and Carmen, be declared a "failure" pursuant to Article V Section 24 (c) of PPA AO No. 12-2018;
- 2. Conduct a mandatory review and evaluation of the terms and conditions in the bid documents; and
- 3. Conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 24 of PPA AO No. 12-2018.
