**RESOLUTION RECOMMENDING SHORT LIST OF CONSULTANTS  
FOR THE CONSULTANCY SERVICES FOR THE TECHNICAL SERVICES  
FOR THE CONDUCT OF SOIL INVESTIGATION AT SELECTED PORTS  
(PACKAGE 11)**

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Technical Services for the Conduct of Soil Investigation at Selected Ports (Package 11), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 31 March 2023, continuously for seven (7) calendar days;

WHEREAS, in response thereto, three (3) consulting firms secured and submitted the Eligibility Documents, namely:

1. R.S. Jardin & Associates
2. Rolando C. Siccion Surveying Office
3. Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV

WHEREAS, after the Eligibility Screening conducted on 19 April 2023, R.S. Jardin & Associates and Rolando C. Siccion Surveying Office, were declared eligible to bid for the project, while Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV was declared "ineligible" for failure to submit the required four (4) pcs. Startling Barrel (owned) in the List of Consultant's Equipment (Form IV), as required in the Eligibility Technical Documents;

WHEREAS, the representative of Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV signified its intention to file a request for reconsideration on their ineligible rating;

WHEREAS, on 20 April 2023, Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV filed a request for reconsideration on their "ineligible" rating, however, the BAC, in a meeting held on 27 April 2023, after due deliberation and upon motion duly made and properly seconded, denied said Request for Reconsideration;

WHEREAS, in accordance with Section 24 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, shortlisting among the eligible consultants should be conducted;

WHEREAS, considering that the required number of shortlisted consultants as advertised should not be more than five (5), R.S. Jardin & Associates and Rolando C. Siccion Surveying Office were automatically considered as shortlisted consultants;

WHEREAS, pursuant to Section 24.5.4 of the 2016 Revised IRR of R.A 9184, "The BAC shall recommend the short list of consultants to the Head of the Procuring Entity for consideration and approval. xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED:

- a. To declare R.S. Jardin & Associates and Rolando C. Siccion Surveying Office as shortlisted consultants.
- b. To recommend for approval and consideration by the Head of the Procuring Entity the shortlist of consultants.
