Award of Contract
PORT TERMINAL MANAGEMENT CONTRACT FOR PORT OF SASA
BAC-PTMC-02-2022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Port Terminal Management Contract (PTMC) for Port of Sasa in The Manila Times, PPA website and in conspicuous places in the PPA premises on 13 April 2022;

WHEREAS, the Minimum Concession Fee for the twenty (20) year PTMC as posted is Php 8,633,252,762.21, exclusive of all taxes;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of Php 150,000.00 namely, International Container Terminal Services, Inc. (ICTSI) and the Joint Venture of Globalport Terminals, Inc. and Globalport Ozamiz Terminal, Inc. (JV of GTI and GOTI);

WHEREAS, during the Opening of Bids on 5 May 2022, the JV of GTI and GOTI was declared "passed" with the requirements of the First Envelope;

WHEREAS, the Second Envelope of the JV of GTI and GOTI was opened and the proposed Concession Fee was read as follows:

WHEREAS, ICTSI submitted a letter dated 6 May 2022 informing the BAC-PTMC of the reason for their non-submission of bid;

WHEREAS, Bid Evaluation was conducted to determine compliance with the requirements of PPA Administrative Order (AO) No. 12-2018; and the Bid Evaluation Report was approved by the BAC-PTMC on 16 May 2022, declaring the JV of GTI and GOTI at its Proposed Concession Fee of Eight Billion Six Hundred Thirty-Five Million Pesos (Php 8,635,000,000.00) exclusive of all taxes, as the Bidder with the Highest Concession Fee;

WHEREAS, Post-Qualification was conducted on 17 May 2022 to determine compliance by the JV of GTI and GOTI with all the requirements, terms and conditions for eligibility and the bidding; and in the Post-Qualification Report, as approved by the BAC-PTMC on 23 May 2022, the proposal of the JV of GTI and GOTI was declared as the Highest Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to declare the JV of GTI and GOTI at its Proposed Concession Fee of Eight Billion Six Hundred Thirty-Five Million Pesos (Php 8,635,000,000.00) exclusive of all taxes, as the Highest Responsive Bidder and to recommend the award of Port Terminal Management Contract for Port of Sasa.




