Award of Contract for the

CONSTRUCTION OF PORT OPERATIONAL AREA,
PORT OF OPOL, MISAMIS ORIENTAL
LFP MOC NO. 008-2022

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Port Operational Area, Port of Opol, Misamis Oriental, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 11 April 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 234,734,704.70;

WHEREAS, in response to the said advertisement, seven (7) bidders secured the Bid Documents in the amount of \$\mathbb{P}\$ 50,000.00, namely:

- 1. MAC Builders
- 2. WTG Construction and Development Corporation
- Equi-Parco Construction Company/ Evenpar Construction and Development Corporation/JV
- 4. UKC Builders, Inc.
- 5. Sunwest Construction and Development Corporation
- 6. Vicente T. Lao Construction
- 7. Khan Kon Chi Construction and Development Corporation

WHEREAS, only six (6) bidders dropped its Technical and Financial Proposals on the scheduled date of the opening of bids. Khan Kon Chi Construction and Development Corporation submitted its bid documents at 1:20 p.m. or after the prescribed deadline of 1:00 p.m. on 04 May 2022, hence the same were not accepted by the BAC Secretariat pursuant to the 2016 Revised IRR of R.A. 9184 on late submission of bids.

WHEREAS, during the opening of bids on 04 May 2022 at 2:00 p.m., the six (6) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the six (6) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 06 May 2022 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 10 May 2022, showed discrepancies between the Total Bid Prices and Unit Bid Prices of UKC Builders, Inc., Sunwest Construction and Development Corporation and WTG Construction and Development Corporation, as follows;

WHEREAS, Equi-Parco Construction Company/ Evenpar Construction and Development Corporation/JV was declared as the Lowest Calculated Bidder in the amount of \$\mathbb{P}\$ 230,988,000.00;

WHEREAS, post-qualification was conducted on 13 & 16 May 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by Equi-Parco Construction Company/ Evenpar Construction and Development Corporation/JV and in the Post-Qualification Report, as approved by the BAC on 24 May 2022, Equi-Parco Construction Company/ Evenpar Construction and Development Corporation/JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare EQUI-PARCO CONSTRUCTION COMPANY/ EVENPAR CONSTRUCTION AND DEVELOPMENT CORPORATION/JV as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Port Operational Area, Port of Opol, Misamis Oriental, in the amount of TWO HUNDRED THIRTY MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND PESOS (P 230,988,000.00), inclusive of taxes, to the said bidder.
