**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY AND
DELIVERY OF PREPAID MOBILE CARDS FOR PHILIPPINE PORTS AUTHORITY
BAC-PGCS-148-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Prepaid Mobile Cards for Philippine Ports Authority, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 29 April 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 1,680,000.00**;

WHEREAS, in response to the said advertisement, only Golden Success Trading & Construction secured the Bid Documents in the amount of **₱ 5,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 25 May 2021 at 10:00 a.m., the lone bidder, Golden Success Trading & Construction was declared "failed" in the requirements of the First Envelope for failure to submit a valid Tax Clearance which expired on February 5, 2021.

WHEREAS, Golden Success Trading & Construction signified no intention to file a request for reconsideration;

WHEREAS, considering that the lone bidder was declared "failed, the BAC, after a motion duly made and properly seconded, declared the bidding for the Supply and Delivery of Prepaid Mobile Cards for Philippine Ports Authority, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply and Delivery of Prepaid Mobile Cards for Philippine Ports Authority, be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A 9184.
2. To resort to Negotiated Procurement (Two-Failed Biddings) under Section 53.1 of the 2016 Revised Implementing Rules and Regulations of R.A 9184.
