WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Port Operations Building, Port of Benoni, Brgy. Benoni, Mahinog, Camiguin, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 11 April 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 159,865,758.22;**

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

1. Vicente T. Lao Construction
2. Jejor's Construction Corporation
3. MAC Builders

WHEREAS, during the opening of bids on 02 May 2022 at 10:00 a.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 06 May 2022 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 10 May 2022, showed discrepancies between the Total Bid Prices and Unit Bid Prices of JeJOR's Construction Corporation, as follows:

WHEREAS, JeJOR's Construction Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 159,295,862.64;


WHEREAS, post-qualification was conducted on 16 & 17 May 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by JeJOR's Construction Corporation and in the Post-Qualification Report, as approved by the BAC on 24 May 2022, JeJOR's Construction Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **JEJOR'S CONSTRUCTION CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Port Operations Building, Port of Benoni, Brgy. Benoni, Mahinog, Camiguin, in the amount of **ONE HUNDRED FIFTY NINE MILLION TWO HUNDRED NINETY FIVE THOUSAND EIGHT HUNDRED SIXTY TWO PESOS AND 64/100 (₱ 159,295,862.64)**, inclusive of taxes, to the said bidder.
