WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Proposed Dredging of the Ports of Pio Duran, Castilla, Bulan, Virac, Tabaco and Jose Panganiban, Bicol Region, in the Manila Standard, a newspaper of general nationwide circulation on 13 April 2018 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₱ 125,126,313.35**;

WHEREAS, in response to the said advertisement, seven (7) prospective bidders secured the Bid Documents in the amount of **₱ 50,000.00**, namely:

1. RT Crisman Builders and Construction Supply
2. Makapa Corporation
3. WTG Construction and Development Corporation
4. F.F. Cruz & Company, Incorporated
5. J.D. Legazpi Construction
6. Anore Construction General Contractor
7. Kwan Sing Construction Corporation

WHEREAS, only four (4) bidders dropped their Technical and Financial Proposals, namely: RT Crisman Builders and Const. Supply, Makapa Corp., WTG Const. and Dev't. Corp. and F.F. Cruz & Co., Inc. Kwan Sing Const. Corp. submitted its letter of withdrawal from participating in the bidding, dated 07 May 2018, and the BAC, finding the reasons cited by Kwan Sing Const. Corp. to be meritorious, accepted their withdrawal from participating in the bidding. J.D. Legazpi Const. and Anore Const. General Contractor did not submit their bid documents nor submitted letters of withdrawal from participating in the bidding before the deadline for submission of bids;

WHEREAS, during the opening of bids on 08 May 2018 at 10:00 a.m., only two (2) bidders were declared "passing" with the requirements of the First Envelope, namely: RT Crisman Builders and Const. Supply and Makapa Corp. WTG Const. and Dev't. Corp. and F.F. Cruz & Co., Inc. were declared "failed" hence, their Second Envelopes were returned unopened and duly received by their respective authorized representatives after signifying no intention to file a request for reconsideration;

WHEREAS, the Financial Proposal of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:


WHEREAS, Bid Evaluation was conducted on 11 May 2018 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 15 May 2018, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of the two (2) bidders;

WHEREAS, Makapa Corp. was declared as the Lowest Calculated Bidder in the amount of ₱ 124,001,356.00;

WHEREAS, post-qualification was conducted on 17-18 May 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by Makapa Corp. and in the Post-Qualification Report, as approved by the BAC on 22 May 2018, Makapa Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **MAKAPA CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Dredging of the Ports of Pio Duran, Castilla, Bulan, Virac, Tabaco and Jose Panganiban, Bicol Region, in the amount of **ONE HUNDRED TWENTY FOUR MILLION ONE THOUSAND THREE HUNDRED FIFTY SIX PESOS (₱ 124,001,356.00)**, inclusive of taxes, to the said bidder.




