WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Construction of Port Operations Building, Port of Babak, Samal, Davao del Norte, in the Manila Standard, a newspaper of general nationwide circulation on 22 March 2018 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **P** 42,744,256.77;

WHEREAS, in response to the said advertisement, only ZET Const. secured and submitted the Bid Documents in the amount of \$\mu\$ 25,000.00;

WHEREAS, during the opening of bids on 17 April 2018 at 2:00 p.m., ZET Const. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of ZET Const. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:
