RESOLUTION DECLARING FAILURE OF BIDDING FOR THE CONSTRUCTION OF MOBILE SHOWER ROOMS FOR PORT MANAGEMENT OFFICES BAC-PGCS-31-2017

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Construction of Mobile Shower Rooms for Port Management Offices, in the Manila Standard, a newspaper of general nationwide circulation on 27 April 2018 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, during the opening of bids on 23 May 2018 no bidders submitted the bid documents before the deadline prescribed for submission thereof;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Construction of Mobile Shower Rooms for Port Management Offices a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

XXX XXX XXX."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To recommend to the Head of the Procuring Entity that the bidding for the Construction of Mobile Shower Rooms for Port Management Offices, be declared a "failure" pursuant to Section 35.1 (c) of the 2016 Revised IRR of R.A. 9184.
- To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, after mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates.
