**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
CAUB PORT DEVELOPMENT PROJECT, BRGY. CAUB, MUN. OF DEL CARMEN,
SIARGAO ISLAND, SURIGAO DEL NORTE
HO-INFRA-PPDD-24-0091**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Caub Port Development Project, Brgy. Caub, Mun. of Del Carmen, Siargao Island, Surigao Del Norte (DOTr Project Downloaded to PPA for Implementation), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 04 May 2024, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 9,718,954.27**;

WHEREAS, in response to the said advertisement, only Danrev Construction and Supply secured the Bid Document in the amount of ₱ 10,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 30 May 2024 at 9:00 a.m., the lone bidder, Danrev Construction and Supply was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Danrev Construction and Supply was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 03 June 2024 to determine if there were arithmetical or computational errors on the submitted bids, and in the Bid Evaluation Report, as approved by the BAC on 04 June 2024, deviations were found in the Bid Proposal of Danrev Construction and Supply. The quantity used for Bill No. 3.02 is 0.97 cu.m. instead of 1.0 cu.m.; Bill No. 3.03 is 21.45 cu.m. instead of 21.0 cu.m.; Bill No. 3.06 is 75.44 sq.m. instead of 75.0 sq.m.; Bill No. 3.12 is 8.28 sq.m. instead of 8.0 sq.m., as specified in the BOQ. Section 32.2.1 (a) of the 2016 Revised IRR of R.A. 9184, provides that:

“Completeness of the bid. Unless the Instructions to Bidders specifically allow partial bids, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified xxx.”

WHEREAS, Danrev Construction and Supply was declared automatically disqualified for failure to conform to the required quantity in the Bill of Quantities;

WHEREAS, considering that the lone bidder was declared “automatically disqualified”, the BAC, after a motion duly made and properly seconded, declared the bidding for the Caub Port Development Project, Brgy. Caub, Mun. of Del Carmen, Siargao Island, Surigao Del Norte, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

“35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx


b) All prospective bidders are declared ineligible;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Halian Concrete Causeway Pier Project, Brgy. Halian, Mun. of Del Carmen, Siargao Island, Surigao Del Norte, be declared a “failure” pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that “all prospective bidders are declared ineligible.”
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Opening of Bids for the Halian Concrete Causeway Pier Project, Brgy. Halian, Mun. of Del Carmen, Siargao Island, Surigao del Norte, and Caub Port Development Project, Brgy. Caub, Mun. of Del Carmen, Siargao Island, Surigao del Norte, held on 29 May 2024 and 30 May 2024, respectively, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: "xxx xxx b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 032-2024 and 033-2024 Series of 2024, recommending that the bidding for the above projects be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
