**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
HALIAN CONCRETE CAUSEWAY PIER PROJECT, BRGY. HALIAN,
MUN. OF DEL CARMEN, SIARGAO ISLAND, SURIGAO DEL NORTE
HO-INFRA-PPDD-24-0092**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Halian Concrete Causeway Pier Project, Brgy. Halian, Mun. of Del Carmen, Siargao Island, Surigao Del Norte (DOTr Project Downloaded to PPA for Implementation), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 04 May 2024, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 4,804,492.21**;

WHEREAS, in response to the said advertisement, only Danrev Construction and Supply secured the Bid Document in the amount of ₱ 5,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 29 May 2024 at 2:00 p.m., Danrev Construction and Supply was declared "failed" for submitting an expired LTO Official Receipt for the pledged one (1) unit Truck;

WHEREAS, Danrev Construction and Supply signified its intention to file a request for reconsideration on its "failed" rating, hence the unopened Second Envelopes were retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, on 30 May 2024, Danrev Construction and Supply submitted a letter manifesting that they will no longer file a request for reconsideration, hence its Second Envelope was returned unopened and duly received by its authorized representative;

WHEREAS, considering that the lone bidder was declared "failed", the BAC, after a motion duly made and properly seconded, declared the bidding for the Halian Concrete Causeway Pier Project, Brgy. Halian, Mun. of Del Carmen, Siargao Island, Surigao Del Norte, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;


xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Halian Concrete Causeway Pier Project, Brgy. Halian, Mun. of Del Carmen, Siargao Island, Surigao Del Norte, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that "all prospective bidders are declared ineligible."
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Opening of Bids for the Halian Concrete Causeway Pier Project, Brgy. Halian, Mun. of Del Carmen, Siargao Island, Surigao del Norte, and Caub Port Development Project, Brgy. Caub, Mun. of Del Carmen, Siargao Island, Surigao del Norte, held on 29 May 2024 and 30 May 2024, respectively, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: "xxx xxx b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 032-2024 and 033-2024 Series of 2024, recommending that the bidding for the above projects be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
