WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Lamao (Limay) Port Improvement Project, Port of Lamao, Limay, Bataan, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 19 April 2024, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 31,298,558.46**;

WHEREAS, in response to the said advertisement, only Goldridge Construction and Development Corporation secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 14 May 2024 at 9:00 a.m., the lone bidder, Goldridge Construction and Development Corporation was declared “passing” with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Goldridge Construction and Development Corporation was opened and declared “passing” with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 20 May 2024 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 21 May 2024, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Goldridge Construction and Development Corporation;

WHEREAS, post-qualification was conducted on 24 May 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by Goldridge Construction and Development Corporation and in the Post-Qualification Report, as approved by the BAC on 29 May 2024, Goldridge Construction and Development Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **GOLDRIDGE CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Lamao (Limay) Port Improvement Project, Port of Lamao, Limay, Bataan, in the amount of **THIRTY ONE MILLION TWO HUNDRED SEVENTY EIGHT THOUSAND FOUR HUNDRED NINETY SEVEN PESOS AND 73/100 (₱ 31,278,497.73)**, inclusive of taxes, to the said bidder.
