WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Service Provider for the Maintenance of Elevator Units, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 23 April 2024, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 11,000,000.00**;

WHEREAS, in response to the said advertisement, only Isometric Enterprises secured the Bid Document in the amount of **₱ 25,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 16 May 2024 at 2:00 p.m., Isometric Enterprises was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Isometric Enterprises was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 17 May 2024 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 22 May 2024, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Isometric Enterprises;

WHEREAS, Isometric Enterprises was declared as the Single Calculated Bidder in the amount of **₱ 10,880,000.00**;

WHEREAS, post-qualification was conducted on 27 May 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by Isometric Enterprises and in the Post-Qualification Report, as approved by the BAC on 04 June 2024, Isometric Enterprises was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **ISOMETRIC ENTERPRISES** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Service Provider for the Maintenance of Elevator Units, in the amount of **TEN MILLION EIGHT HUNDRED EIGHTY THOUSAND PESOS (PHP 10,880,000.00)**, inclusive of taxes, to the said bidder.
