### **RESOLUTION RECOMMENDING SHORT LIST OF CONSULTANTS FOR THE CONSULTANCY SERVICES FOR THE CONDUCT OF FEASIBILITY STUDIES AND FORMULATION OF MASTER PLANS AT SELECTED PORTS**

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Conduct of Feasibility Studies and Formulation of Master Plans at Selected Ports, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 24 May 2024, continuously for seven (7) calendar days;

WHEREAS, in response thereto, five (5) consulting firms secured the Eligibility Documents, namely:

1. Science & Vision for Technology, Incorporated
2. Syconsult, Incorporated
3. Gammacon Builders, Inc.
4. Cest Incorporated
5. Schema Konsult, Inc.

WHEREAS, Science & Vision for Technology, Inc. and Syconsult Inc. submitted their eligibility documents as a Joint Venture before the deadline for the submission of eligibility documents on 05 June 2024. Schema Konsult, Inc. submitted its eligibility document at 9:07 a.m. or after the prescribed deadline for submission thereof, hence the document was stamped "LATE" and not accepted by the BAC Secretariat, pursuant to the 2016 Revised IRR of R.A. 9184 on late submission of bids. Cest Incorporated did not submit their eligibility documents, nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission thereof, while Gammacon Builders, Inc. submitted its letter of withdrawal, dated 04 June 2024, from participating in the bidding, and the BAC, finding the reasons to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS, after the Eligibility Screening conducted on 05 June 2024 at 10:00 a.m., Science & Vision for Technology, Inc./Syconsult Inc./JV was declared eligible to bid for the project;

WHEREAS, in accordance with Section 24 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, shortlisting among the eligible consultants should be conducted;

WHEREAS, considering that the required number of shortlisted consultants as advertised should not be more than five (5), Science & Vision for Technology, Inc./ Syconsult Inc./ JV was automatically considered as shortlisted consultant;


WHEREAS, pursuant to Section 24.5.4 of the 2016 Revised IRR of R.A 9184, "The BAC shall recommend the short list of consultants to the Head of the Procuring Entity for consideration and approval. xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED:

- a. To declare Science & Vision for Technology, Inc./Syconsult Inc./JV as shortlisted consultant.
- b. To recommend for approval and consideration of the Head of the Procuring Entity the shortlist of consultant.
