RESOLUTION RECOMMENDING SHORT LIST OF CONSULTANTS FOR THE TECHNICAL SERVICES FOR THE CONDUCT OF SOIL INVESTIGATION AT SELECTED PORTS (PACKAGE 12)

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Technical Services for the Conduct of Soil Investigation at Selected Ports (Package 12), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 24 May 2024, continuously for seven (7) calendar days;

WHEREAS, in response thereto, five (5) consulting firms secured and submitted the Eligibility Documents, namely:

1. R.S. Jardin & Associates
2. Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV
3. Terms Concrete and Materials Testing
4. Solar Surveying Corp.
5. Levin Ace Geotechnical Services

WHEREAS, after the Eligibility Screening conducted on 05 June 2024 at 2:00 p.m., R.S. Jardin & Associates, Gammacon Builders, Inc./ Geoinnovative Specialists Inc./JV, and Solar Surveying Corp. were declared eligible to bid for the project, while Terms Concrete and Materials Testing and Levin Ace Geotechnical Services were declared "automatically disqualified" for failure to comply with the required bid submission under Eligibility Documents of the Eligibility Data Sheet, which states that "xxx Each prospective bidder shall submit one (1) original and six (6) copies of the duly accomplished Eligibility Documents, properly labelled, book-bound, with hard bound with index tabs. Screw-bound, ring-bound and combo-bound documents are not acceptable.xxx" The submitted eligibility documents of Levin Ace Geotechnical Services are ring-bound and with soft cover, while the documents submitted by Terms Concrete and Materials Testing are not book-bound and with soft cover;

WHEREAS, in accordance with Section 24 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, shortlisting among the eligible consultants should be conducted;

WHEREAS, considering that the required number of shortlisted consultants as advertised should not be more than five (5), R.S. Jardin & Associates, Gammacon Builders, Inc./ Geoinnovative Specialists Inc./JV, and Solar Surveying Corp. were automatically considered as shortlisted consultants;


