WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Surface Treatment of Metal Roof at the PPA Head Office Motorpool Building, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 08 April 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 15,000,000.00**;

WHEREAS, in response to the said advertisement, only Enecon Philippines, Inc. secured the Bid Document in the amount of **₱ 25,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 04 May 2022 at 10:00 a.m., Enecon Philippines, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Enecon Philippines, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 12 May 2022 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 13 May 2022, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Enecon Philippines, Inc.;

WHEREAS, Enecon Philippines, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 14,129,094.10;

WHEREAS, post-qualification was conducted on 18 May 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by Enecon Philippines, Inc. and in the Post-Qualification Report, as approved by the BAC on 23 May 2022, Enecon Philippines, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **ENECON PHILIPPINES, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Surface Treatment of Metal Roof at the PPA Head Office Motorpool Building, in the amount of **FOURTEEN MILLION ONE HUNDRED TWENTY NINE THOUSAND NINETY FOUR PESOS AND 10/100 (PHP 14,129,094.10)**, inclusive of taxes, to the said bidder.

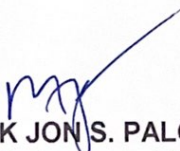
