RESOLUTION RECOMMENDING SHORT LIST OF CONSULTANTS FOR THE CONSULTANCY SERVICES FOR THE INVENTORY AND STRUCTURAL INVESTIGATION SURVEY OF ALL MARINE STRUCTURES AND ITS ACCESSORIES AT SELECTED PORTS NATIONWIDE (PACKAGE 3)

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Inventory and Structural Investigation Survey of all Marine Structures and its Accessories at Selected Ports Nationwide (Package 3), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 24 May 2024, continuously for seven (7) calendar days;

WHEREAS, in response thereto, five (5) consulting firms secured and submitted their Eligibility Documents, namely:

1. E. H. Sison Engineers, Co.
2. Syconsult, Incorporated
3. Science & Vision for Technology, Incorporated
4. Gammacon Builders Inc.
5. Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV

WHEREAS, Syconsult Inc. and Science & Vision for Technology, Inc. submitted their eligibility documents as a Joint Venture. Likewise, Gammacon Builders Inc. submitted its eligibility document as a Joint Venture with Geoinnovative Specialists Inc.;

WHEREAS, after the Eligibility Screening conducted on 06 June 2024 at 10:00 a.m., E.H. Sison Engineers, Co. and Syconsult Inc./Science & Vision for Technology, Inc./JV were declared eligible to bid for the project. Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV was declared "ineligible" for failure to submit PRC License and PTR of the pledged Geodetic Engineer, Clipper Besin. The submitted PRC License is for Civil Engineer and not as Geodetic Engineer;

WHEREAS, considering that there was no representative from Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV, the BAC presumed that the consulting firm will file a request for reconsideration;

WHEREAS, Gammacon Builders, Inc./Geoinnovative Specialists Inc./JV did not file a request for reconsideration within the prescribed deadline for filing thereof;

WHEREAS, in accordance with Section 24 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, shortlisting among the eligible consultants should be conducted;

WHEREAS, considering that the required number of shortlisted consultants as advertised should not be more than five (5), E.H. Sison Engineers, Co. and Syconsult Inc./Science & Vision for Technology, Inc./JV were automatically considered as shortlisted consultants;

WHEREAS, pursuant to Section 24.5.4 of the 2016 Revised IRR of R.A 9184, "The BAC shall recommend the short list of consultants to the Head of the Procuring Entity for consideration and approval. xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED:

- a. To declare E.H. Sison Engineers, Co. and Syconsult Inc./Science & Vision for Technology, Inc./JV as shortlisted consultants.
- b. To recommend for approval and consideration by the Head of the Procuring Entity the shortlist of consultants.
