## RESOLUTION DECLARING FAILURE OF BIDDING FOR THE CONSTRUCTION OF PORT OPERATIONS BUILDING AND TRANSIT SHED, PORT OF MASBATE, MASBATE CITY

LFP MSB No. 015-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Port Operations Building and Transit Shed, Port of Masbate, Masbate City, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 21 May 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be bid as posted/advertised is **₽ 142,613,052.34**;

WHEREAS, in response to the said advertisement, only Jinnel-Belvoir Corp. secured and submitted the Bid Documents in the amount of ₽ 50,000.00;

WHEREAS, during the opening of bids on 11 June 2019 at 11:00 a.m., Jinnel-Belvoir Corp. was automatically disqualified for failure to comply with the requirement of the Bid Data Sheet and Important Reminders for the Pre-Bid Conference that the Bid Proposals should be properly labeled, and with index tabs;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Construction of Port Operations Building and Transit Shed, Port of Masbate, Masbate City, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

b) All prospective bidders are declared ineligible;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

 To recommend to the Head of the Procuring Entity that the bidding for the Construction of Port Operations Building and Transit Shed, Port of Masbate, Masbate City, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184; To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

SUBJECT : BAC RESOLUTIONS DECLARING FAILURE OF BIDDING

This has reference to the Opening of Bids for the Proposed Rehabilitation of Four (4) River Crossing Terminals Along Pasig River, Manila and Construction of Port Operations Building and Transit Shed, Port of Masbate, Masbate City, held on 11 June 2019 at 10:00 a.m. and 11:00 a.m., respectively. Both biddings were declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: a) No bids are received; b) All prospective bidders are declared ineligible; xxx xxx xxx", considering that the lone bidder for the Proposed Rehabilitation of Four (4) River Crossing Terminals Along Pasig River, Manila, JVN Construction and Trading. submitted a letter of withdrawal from participating in the bidding, while the lone bidder for the Construction of Port Operations Building and Transit Shed, Port of Masbate, Masbate City, Jinnel-Belvoir Corporation failed to comply with the requirement of the Bid Data Sheet and Important Reminders for the Pre-Bid Conference that the Bid Proposals should be properly labelled, and with index tabs.

In view thereof, we are submitting herewith BAC Resolution Nos. 032-2019 Series of 2019 and 033-2019 Series of 2019, recommending that the bidding for the Proposed Rehabilitation of Four (4) River Crossing Terminals Along Pasig River, Manila and Construction of Port Operations Building and Transit Shed, Port of Masbate, Masbate City be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of RA 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
