Award of Contract for the MANOC MANOC CARGO PORT PROJECT, PORT OF MANOC MANOC, MALAY, AKLAN

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Manoc Manoc Cargo Port Project, Port of Manoc Manoc, Malay, Aklan, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 03 May 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is # 134,170,466.65;

WHEREAS, in response to the said advertisement, three (3) bidders secured and submitted the Bid Documents in the amount of \$\mathbb{P}\$ 50,000.00, namely:

- 1. MAC Builders
- 2. L.N.R. Construction
- 3. Khan Kon Chi Construction and Development Corporation

WHEREAS, during the opening of bids on 13 May 2019 at 11:00 a.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 28 May 2019 to determine if there were arithmetical or computational errors on the submitted bid proposals of the three (3) bidders, and the Bid Evaluation Report, as approved by the BAC on 29 May 2019, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of the three (3) bidders;

WHEREAS, however, it was found out that L.N.R. Const. pledged the same manpower and equipment on their ongoing Villaba Port Development Project and Manoc Manoc Cargo Port Project, hence L.N.R. Const. was declared "failed" and was notified of its disqualification.;

WHEREAS, Khan Kon Chi Const. & Dev't. Corp. was declared as the Lowest Calculated Bidder in the amount of # 132,828,205.91;

WHEREAS, post-qualification was conducted on 02 June 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Khan Kon Chi Const. and Dev't. and in the Post-Qualification Report, as approved by the BAC on 04 June 2019, Khan Kon Chi Const. and Dev't. Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Manoc Manoc Cargo Port Project, Port of Manoc Manoc, Malay, Aklan, in the amount of ONE HUNDRED THIRTY TWO MILLION EIGHT HUNDRED TWENTY EIGHT THOUSAND TWO HUNDRED FIVE AND 91/100 PESOS (P 132,828,205.91), inclusive of taxes, to the said bidder.
