Award of Contract for the  
**PROPOSED EXTENSION OF R.C. WHARF, PORT OF CANTILAN,  
SURIGAO DEL SUR**  
LFP SUG NO. 008-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Extension of R.C. Wharf, Port of Cantilan, Surigao Del Sur, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 03 May 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 95,128,012.70**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of **₱ 50,000.00**, namely:

1. A.T. Tan Construction Corporation
2. Vicente T. Lao Construction
3. Khan Kon Chi Construction and Development Corp.
4. Premium Megastructures, Inc.

WHEREAS, only three (3) bidders dropped its Technical and Financial Proposals on the scheduled date of the opening of bids. Premium Megastructures, Inc. submitted its letter of withdrawal from participating in the bidding, dated 28 May 2021, and the BAC, finding the reason to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 28 May 2021 at 2:00 p.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 02 June 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 03 June 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of A.T. Tan Construction Corp.;

WHEREAS, Vicente T. Lao Construction Company was declared as the Lowest Calculated Bidder in the amount of ₱ 93,895,313.30;

WHEREAS, the evaluated and corrected bids of A.T. Tan Construction Corp. was found to be higher than the Approved Budget for the Contract (ABC), hence was declared "disqualified" pursuant to Section 32.2.4 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"Total calculated bid prices, as evaluated and corrected for computational errors, and other bid modifications, which exceed the ABC shall be disqualified."

WHEREAS, post-qualification was conducted on 09 June 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Vicente T. Lao Construction Company and in the Post-Qualification Report, as approved by the BAC on 18 June 2021, Vicente T. Lao Construction Company was declared as the Lowest Calculated and Responsive Bidder;



NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **VICENTE T. LAO CONSTRUCTION CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Extension of R.C. Wharf, Port of Cantilan, Surigao Del Sur, in the amount of **NINETY THREE MILLION EIGHT HUNDRED NINETY FIVE THOUSAND THREE HUNDRED THIRTEEN PESOS AND 30/100 (₱ 93,895,313.30)**, inclusive of taxes, to the said bidder.
