**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF SERVERS
BAC-PGCS-021-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of Servers, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 19 May 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ **18,000,000.00**;

WHEREAS, in response to the said advertisement, only Dalaz Enterprises secured the Bid Documents in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposal;


WHEREAS, during the opening of bids on 16 June 2021 at 10:00 a.m., the lone bidder, was declared "failed" with the requirements of the First Envelope, for failure to submit the Schedule of Requirements Form.

WHEREAS Dalaz Enterprises filed a request for reconsideration on their "failed" rating, however, the BAC, in a meeting held on 22 June 2021, after due deliberation and upon motion duly made and properly seconded denied said Request for Reconsideration;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply, Delivery, Installation and Commissioning of Servers, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that there was no eligible bidder for the project.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

S U B J E C T : Resolutions Declaring Failure of Bidding

This has reference to the Opening of Bids for the Supply and Delivery of Hepa-Certified Air Purifiers; Supply, Delivery, Installation and Commissioning of Servers; and Supply, Delivery, Installation and Commissioning of Customized Asset Status and Performance Automation System (Hardware & Software), held on 15 and 16 June 2021, respectively, which were all declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible."

In view thereof, we are submitting herewith BAC-PGCS Resolution Nos. 056-2021; 057-2021 and 058-2021 Series of 2021, recommending that the bidding for the above projects be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
