**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
SUPPLY AND DELIVERY OF HEPA-CERTIFIED AIR PURIFIERS
BAC-PGCS-009-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of HEPA-Certified Air Purifiers, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 19 May 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 5,000,000.00**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of **₱ 5,000.00**, namely:

1. Asahi Design Center Inc.
2. E. Aglahi Urban Builders
3. YT Green Aire Corp.

WHEREAS, Asahi Design Center Inc. and E. Aglahi Urban Builders dropped their Technical and Financial Proposals in the bid boxes before the deadline prescribed for submission of bid documents. YT Green Aire Corp. submitted its bid documents at 1:22 p.m. or after the prescribed deadline of 1:00 p.m. on 15 June 2021, hence the same were not accepted by the BAC Secretariat, pursuant to the 2016 Revised IRR of R.A. 9184 on late submission of bids.

WHEREAS, during the opening of bids on 15 June 2021 at 2:00 p.m., the two (2) bidders, were declared "failed" with the requirements of the First Envelope;

WHEREAS, Asahi Design Center Inc. was declared "failed" for failure to submit Brochure for the goods being offered while E. Aglahi Urban Builders was likewise declared "failed" for failure to submit a valid DTI Registration Certificate since the one indicated in Annex "A" of the PhilGEPS Certificate of Registration – Platinum Membership had already expired;

WHEREAS, the two (2) bidders filed a request for reconsideration on their "failed" ratings, however, the BAC, in a meeting held on 22 June 2021, after due deliberation and upon motion duly made and properly seconded, denied said Requests for Reconsideration;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Supply and Delivery of HEPA-Certified Air Purifiers, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that all prospective bidders are declared ineligible to bid for the project.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

S U B J E C T : Resolutions Declaring Failure of Bidding

This has reference to the Opening of Bids for the Supply and Delivery of Hepa-Certified Air Purifiers; Supply, Delivery, Installation and Commissioning of Servers; and Supply, Delivery, Installation and Commissioning of Customized Asset Status and Performance Automation System (Hardware & Software), held on 15 and 16 June 2021, respectively, which were all declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible."

In view thereof, we are submitting herewith BAC-PGCS Resolution Nos. 056-2021; 057-2021 and 058-2021 Series of 2021, recommending that the bidding for the above projects be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
