WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Implementation of Kiosk System for Port Customer Satisfaction Survey (PCSS) for PPA Baseports and Terminals, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 19 May 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 87,400,000.00**;

WHEREAS, in response to the said advertisement, only Cosmotech Philippines, Inc. secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 09 June 2022 at 10:00 a.m., Cosmotech Philippines, Inc. was declared "failed" with the requirements of the First Envelope (Technical Component), for failure to comply with Item 12 (b) of the Terms of Reference, which requires that the System Provider must have undertaken a project with nationwide deployment of hardware and software in more than 80 locations all over the country;

WHEREAS, Cosmotech Philippines, Inc. signified its intention to file a request for reconsideration, hence, their unopened Second Envelope was retained by the BAC until the request for reconsideration was resolved;

WHEREAS, Cosmotech Philippines, Inc. filed a request for reconsideration on 10 June 2022, and the BAC, in a meeting held on 16 June 2022, after due deliberation, granted said request for reconsideration;

WHEREAS, the Financial Proposal of Cosmotech Philippines, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 22 June 2022 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 23 June 2022, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Cosmotech Philippines, Inc.;

WHEREAS, Cosmotech Philippines, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 87,350,000.00;

WHEREAS, post-qualification was conducted on 23 June 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by Cosmotech Philippines, Inc. and in the Post-Qualification Report, as approved by the BAC on 28 June 2022, Cosmotech Philippines, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **COSMOTECH PHILIPPINES, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery, Installation and Implementation of Kiosk System for Port Customer Satisfaction Survey (PCSS) for PPA Baseports and Terminals, in the amount of **EIGHTY SEVEN MILLION THREE HUNDRED FIFTY THOUSAND PESOS (PHP 87,350,000.00)**, inclusive of taxes, to the said bidder.
