WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Back-Up Area and RoRo Ramp, Port of Tapal, Bohol, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 03 May 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 56,559,225.82**;

WHEREAS, in response to the said advertisement, only Mamsar Const. and Industrial Corp./JFAP Const./JV secured and submitted the Bid Documents in the amount of ₱ 50,000.00;

WHEREAS, during the opening of bids on 23 May 2019 at 2:00 p.m., Mamsar Const. and Industrial Corp./JFAP Const./JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Mamsar Const. and Industrial Corp./JFAP Const./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 28 May 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 29 May 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Mamsar Const. and Industrial Corp./JFAP Const./JV;

WHEREAS, Mamsar Const. and Industrial Corp./JFAP Const./JV was declared as the Single Calculated Bidder in the amount of ₱ 56,285,488.85, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, post-qualification was conducted on 1-2 June 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Mamsar Const. and Industrial Corp./JFAP Const./JV, and in the Post-Qualification Report, as approved by the BAC on 04 June 2019, Mamsar Const. and Industrial Corp./JFAP Const./JV was declared as the Single Calculated and Responsive Bidder;


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **MAMSAR CONSTRUCTION AND INDUSTRIAL CORPORATION/JFAP CONSTRUCTION/JOINT VENTURE** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Back-Up Area and RoRo Ramp, Port of Tapal, Bohol, in the amount of **FIFTY SIX MILLION TWO HUNDRED EIGHTY FIVE THOUSAND FOUR HUNDRED EIGHTY EIGHT AND 85/100 PESOS (₱ 56,285,488.85)**, inclusive of taxes, to the said bidder.
