Award of Contract for the RECONSTRUCTION OF RC PIER & CONSTRUCTION OF RORO RAMP PORT OF CARMEN, SAN AGUSTIN, ROMBLON LFP BGS NO. 009-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Reconstruction of RC Pier & Construction of RoRo Ramp, Port of Carmen, San Agustin, Romblon, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 26 April 2019, continuously for seven (7) calendar days:

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₽ 44,084,950.00;

WHEREAS, in response to the said advertisement, only D.K. Jocson Construction secured and submitted the Bid Documents in the amount of ₽ 25,000.00;

WHEREAS, during the opening of bids on 16 May 2019 at 2:00 p.m., D.K. Jocson Construction was declared "passing" with the requirements of the First Envelope:

WHEREAS, the Financial Proposal of D.K. Jocson Construction was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

Jocson Construction and in the Post-Qualification Report, as approved by the BAC on 29 May 2019, D.K. Jocson Construction was declared as the Single Calculated and Responsive Bidder;
