**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROCUREMENT OF SERVICES FOR PPA HEAD OFFICE 2ND FLOOR CONCRETE
DECK CLADDING AND WATERPROOFING SYSTEM
BAC-PGCS-109-2020**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Services for PPA Head Office 2nd Floor Concrete Deck Cladding and Waterproofing System, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 06 March 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 4,552,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 10,000.00, namely:

1. Thaumaturgy Trade Philippines
2. Enecon Philippines, Inc.

WHEREAS, during the opening of bids on 22 June 2020 at 2:00 p.m., the two (2) bidders were declared “failed” with the requirements of the First Envelope, for the following reasons:

THAUMATURGY TRADE PHILIPPINES

- Failed to submit a warranty for all applications such as putty, first, second, third layer coating for no less than two (2) year period which covers peeling off or blistering of the material due to workmanship, as required in Item IX. Warranty of the Terms of Reference (TOR).
- PCAB License did not indicate “Painting Works” under its other classifications.

ENECON PHILIPPINES, INC.

- Failed to indicate “comply or not comply” in the Statement of Compliance.
- Altered the prescribed form for the Omnibus Sworn Statement.
- Failed to submit a warranty for all applications as required in Item IX. Warranty of the TOR.

WHEREAS, the Second Envelope of Enecon Philippines, Inc. was returned unopened and duly received by its authorized representative after signifying no intention to file a request for reconsideration;

WHEREAS, Thaumaturgy Trade Philippines filed a request for reconsideration on their "failed" rating, and the BAC, in a meeting held on 30 June 2020, after due deliberation, agreed to deny said request for reconsideration;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Services for PPA Head Office 2nd Floor Concrete Deck Cladding and Waterproofing System, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that all prospective bidders are declared ineligible.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Bidding for the Procurement of Services for PPA Head Office 2nd Floor Concrete Deck Cladding and Waterproofing System held on 22 June 2020, which was declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 043-2020 Series of 2020, recommending that the bidding for the Procurement of Services for PPA Head Office 2nd Floor Concrete Deck Cladding and Waterproofing System be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
