**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROCUREMENT OF TECHNICAL SUPPORT SERVICES FOR PHILIPPINE PORTS
AUTHORITY'S CORE APPLICATION
BAC-PGCS-117-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Procurement of Technical Support Services for the Philippine Ports Authority's Core Application, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 May 2021, continuously for seven (7) calendar days;

WHEREAS, in response to the said advertisement, only Diversified Infrastructure and Architectural Developments Works Corporation secured the Eligibility Documents;

WHEREAS, after the Eligibility Screening conducted on 03 June 2021, Diversified Infrastructure and Architectural Developments Works Corporation was declared eligible to bid for the project;

WHEREAS, in accordance with Section 24 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184, shortlisting among the eligible consultants should be conducted;

WHEREAS, considering that only Diversified Infrastructure and Architectural Developments Works Corporation was declared eligible to bid for the project and the required number of shortlisted consultants as advertised should not be more than five (5), Diversified Infrastructure and Architectural Developments Works Corporation was automatically considered as shortlisted;

WHEREAS, during the opening of the Technical Proposal on 30 June 2021 at 2:00 p.m., the lone bidder, was declared "failed" with the requirements of the First Envelope, for failure to comply with the prescribed form of the Omnibus Sworn Statement and failure to submit proof of authority for the authorized representative;

WHEREAS, Diversified Infrastructure and Architectural Developments Works Corporation signified its intention to file a request for reconsideration, however, on even date, it submitted a letter manifesting that they will no longer file a request for reconsideration;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Consultancy Services for the Procurement of Technical Support Services for the Philippine Ports Authority's Core Application, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that "all prospective bidders are declared ineligible."
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.



This has reference to the Opening of Bids for the Procurement of Technical Support Services for Philippine Ports Authority's Core Application, held on 30 June 2021, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 062-2021 Series of 2021, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
