WHEREAS, in response to the said advertisement, only Cytracon Corporation secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 22 June 2020 at 10:00 a.m., Cytracon Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Cytracon Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:
