WHEREAS, during the opening of bids on 29 May 2019 at 10:30 a.m., KIT Properties/Beyondsight Philippines, Inc./iPointeast, Inc./JV was declared "passing" with the requirements of the First Envelope. Annex Digital, Inc./Advance Remote Managed Security Services, Inc./JV was declared "failed;"

WHEREAS, Annex Digital, Inc./Advance Remote Managed Security Services, Inc./JV filed a request for reconsideration on their "failed" rating, and the BAC, in a meeting held on 04 June 2019, after due deliberation, denied said request for reconsideration;

WHEREAS, the Financial Proposal of KIT Properties/Beyondsight Philippines, Inc./iPointeast, Inc./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:
