WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Back-Up Area, Port of Getafe, Bohol, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 21 May 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 163,296,490.50**;

WHEREAS, in response to the said advertisement, three (3) bidders secured and submitted the Bid Documents in the amount of **₱ 50,000.00**, namely:

1. WTG Construction & Development Corporation
2. Sunwest Construction & Development Corporation
3. Hi-Tone Construction & Development Corporation/  
L.N.R. Construction/Joint Venture

WHEREAS, during the opening of bids on 11 June 2019 at 2:00 p.m., only two (2) bidders were declared "passing" with the requirements of the First Envelope, namely: WTG Construction & Development Corporation and Sunwest Construction & Development Corporation, Hi-Tone Construction & Development Corporation/L.N.R. Construction/Joint Venture was declared "failed" and signified its intention to file a request for reconsideration, however, no request was filed by them;

WHEREAS, the Financial Proposal of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 17 June 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 18 June 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of the two (2) bidders;

WHEREAS, despite said discrepancies, the ranking of the two (2) bidders were not affected, hence WTG Construction & Development Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 162,355,979.71, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, post-qualification was conducted on 25 June 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by WTG Construction & Development Corporation and in the Post-Qualification Report, as approved by the BAC on 26 June 2019, WTG Construction & Development Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **WTG CONSTRUCTION & DEVELOPMENT CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Back-Up Area, Port of Getafe, Bohol, in the amount of **ONE HUNDRED SIXTY TWO MILLION THREE HUNDRED FIFTY FIVE THOUSAND NINE HUNDRED SEVENTY NINE AND 71/100 PESOS (₱ 162,355,979.71)**, inclusive of taxes, to the said bidder.
