WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Twenty Five (25) Units Specific Purpose Motor Vehicles, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 01 June 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 250,000,000.00**;

WHEREAS, in response to the said advertisement, only BT Industries, Inc. secured the Bid Documents, and submitted its Technical and Financial Proposals before the prescribed deadline for submission thereof;

WHEREAS, during the opening of bids on 30 June 2020 at 10:00 a.m., BT Industries, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of BT Industries, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 06 July 2020 to determine if there were arithmetical or computational errors on the submitted bid, of BT Industries, Inc.;

WHEREAS, in a letter dated 30 June 2020 and pursuant to Section 32.1 of the 2016 Revised IRR of RA 9184, the BAC, thru the Head Secretariat, requested clarification from BT Industries, Inc. on its submitted bid proposal in the amount of "HUNDRED FORTY NINE MILLION FIVE HUNDRED THOUSAND PESOS (₱ 249,500,000.00)."

WHEREAS, in a letter reply dated 01 July 2020, BT Industries, Inc. clarified that the actual bid offer is TWO HUNDRED FORTY NINE MILLION FIVE HUNDRED THOUSAND PESOS (₱ 249,500,000.00) consistent with the amount in figures appearing on their submitted Bid Form and Schedule of Prices;



WHEREAS, post-qualification was conducted on 08 July 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by BT Industries, Inc. and in the Post-Qualification Report, as approved by the BAC on 10 July 2020, BT Industries, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BT INDUSTRIES, INC.** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply and Delivery of Twenty Five (25) Units Specific Purpose Motor Vehicles, in the amount of **TWO HUNDRED FORTY NINE MILLION FIVE HUNDRED THOUSAND PESOS (₱ 249,500,000.00)**, inclusive of taxes, to the said bidder.
