WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery and Commissioning of Multi-Function Radio Communications with Centralized Dispatching and Recording System, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 06 May 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 50,000,000.00**;

WHEREAS, in response to the said advertisement, only BT Industries, Inc. secured the Bid Documents in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 02 June 2021 at 10:00 a.m., BT Industries, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of BT Industries, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 09 June 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 10 June 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of BT Industries, Inc.;

WHEREAS, BT Industries, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 48,800,000.00;

WHEREAS, post-qualification was conducted on 17 June 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by BT Industries, Inc. and in the Post-Qualification Report, as approved by the BAC on 22 June 2021, BT Industries, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BT INDUSTRIES, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery and Commissioning of Multi-Function Radio Communications with Centralized Dispatching and Recording System, in the amount of **FORTY EIGHT MILLION EIGHT HUNDRED THOUSAND PESOS (PHP 48,800,000.00)**, inclusive of taxes, to the said bidder.
